Champaign-Urbana Public Health District Annual Report—2011

The Champaign-Urbana Public Health District (CUPHD) has worked since 1937 to prevent disease and promote public health.

In 1996, the Champaign County Public Health Department was formed by a referendum of county voters bringing many of the same public health services to Champaign County residents living outside Champaign-Urbana.



Together, these agencies provide a host of vital services to all Champaign-Urbana residents, as well as selected services to Champaign County residents at large. Public Health services include, but are not limited to, environmental health inspections and permits; disease tracking, reporting, and investigation; HIV counseling and testing, prevention, and management; sexually transmitted disease testing and treatment; dental services for children; education and health promotion; preventive services and case management for women; immunizations; and an array of other services to pregnant women, children, teenagers, and adults of all ages.

This is a progressive report of Public Health services provided by the Champaign-Urbana Public Health District in 2011.

Mission Statement

The mission of the Champaign-Urbana Public Health District is to improve the health, safety, and well-being of the community through prevention, education, collaboration, and regulation.

Letter from the Administrator

The Leadership Team at the Champaign-Urbana Public Health District spent a great deal of time in 2011 planning for our agency's future. We met for a two-day intensive workshop to create a new Strategic Plan. The areas to be addressed in our new Strategic Plan are:

Good customer service is an integral part of our job responsibilities and should not be seen as an extension of it. In fact, it is one of the fundamental responsibilities of Public Health: To provide the best customer service experience to all our community residents. Improving customer service will be one of the four priorities of CUPHD and this will be measured by input from the clients we serve.

Communication was identified as a significant issue in the initial and follow-up survey to all staff. Only 26.5 percent of the respondents felt that communication was adequate at CUPHD. There were several suggestions about improving all forms of communication.

Maintaining a positive and productive work environment is critical for an organization. Addressing this issue is a necessary function. This includes the management's understanding of employee's duties, responsibilities, and challenges. It also includes employee safety and security concerns and strategies on improving employee relationships among each member of the CUPHD team including the management.

Finance was selected as one of the priorities for the current strategic plan. Employees were concerned about the financial status of the agency, and this was expressed in the survey. The current State and Federal budget cuts and subsequent reduction in grant funding were also considered. CUPHD must look for new ways to cuts costs and increase revenues while keeping service quality high.

The Leadership Team also investigated options for moving into the future with Electronic Medical Records (EMR). We finally settled on the Insight product by Netsmart. Insight is an electronic medical record that is specifically designed for public health departments. We also decided on Dentrix Enterprise for our electronic dental records. By this time next year, CUPHD will be exclusively using electronic medical records for the services that we provide. This will also enable us to move forward with participation in Health Information Exchanges and meaningful use of data.

CUPHD also took major steps towards National Accreditation by the Public Health Accreditation Board (PHAB). Public health department accreditation is defined as the development of a set of standards, a process to measure health department performance against those standards, and reward or recognition for those health departments who meet the standards.

PHAB's public health department accreditation process seeks to advance quality and performance within public health departments. Accreditation standards define the expectations for all public health departments that seek to become accredited. National public health department accreditation has been developed because of the desire to improve service, value, and accountability to stakeholders.

Accreditation through PHAB provides a means for a department to identify performance improvement opportunities, to improve management, develop leadership, and improve relationships with the community. The process is one that will challenge the health department to think about what business it does and how it does that business. It will encourage and stimulate quality and performance improvement in the health department. It will also stimulate greater accountability and transparency.

The steps taken by CUPHD in 2011 will help us grow, improve, and meet the changing needs of our community. The changes will also ensure that CUPHD remains a leader in Public Health innovation and services. As we enter our 75th year of service, we are very cognizant of our responsibility to future citizens of Champaign-Urbana.



Champaign-Urbana Public Health District Board of Health

The Champaign-Urbana Public Health District (CUPHD) is governed by a three-person voting board made up of elected Champaign-Urbana officials. Advisors to the board include an appointed medical advisor and treasurer. This governing board is directly responsible for overall operations, financial stability, and the community standing of the Champaign-Urbana Public Health District.

"CUPHD is a special district; the statute requires that the township supervisors of the City of Champaign Township, Cunningham Township, and the Chairperson of the Champaign County Board serve as the CUPHD Board of Health. An election is held annually in April to elect officers of the board.

I was appointed to the position of Cunningham Township Supervisor in January 1996 to complete the term of

my predecessor. I was re-elected to the position of Supervisor in April 2009 and will continue in that position through April 2013. I am part of the Illinois Association of Boards of Health and have participated in the State Health Improvement Plan.

Cunningham Township is a local unit of government which provides financial and medical benefits to eligible persons within the township. I am the Chief Executive Officer of the township and am responsible for preparing the budget, levy, and overseeing the administration of the General Assistance program.

Although my official role as a CUPHD board member didn't begin until January 1996, I became very familiar with CUPHD services when I began working at Cunningham Township in 1980. I have seen the role of public health greatly expand over the years to what it is today. My experience in working for local government is essential to serving as a board member.

Champaign County Medical Reserve Corps (MRC)



Medical Reserve Corps units are community-based and function as a way to locally organize and utilize volunteers who want to donate their time and expertise to promote healthy living throughout the year, and to prepare for and respond to emergencies. MRC volunteers supplement existing local emergency and public health resources.

MRC volunteers include medical and public health professionals such as physicians, nurses, pharmacists, dentists, veterinarians, and epidemiologists. Other community members, such as interpreters, chaplains, office workers, and legal advisors can fill other vital support positions.

The Champaign County Medical Reserve Corps here at CUPHD has been in place for over four years. In 2011, the Champaign County MRC continued to grow and recruit volunteers—now at 38 members. Multiple training opportunities were offered to MRC this year to engage them in emergency preparedness efforts. The program continues to grow and is an asset to the community.

Communicable Disease Corner

Section 690.100 of the Illinois Administrative Code defines a list of 63 diseases that are declared to be contagious, infectious, or communicable and may be dangerous to the public health. Each suspected or diagnosed case needs to be reported to the local health authority, who shall subsequently report each case to the Illinois Department of Public Health.

Each year the Champaign-Urbana Public Health District staff investigates over 100 reportable communicable diseases. Reports come from hospitals, clinics, laboratories, veterinary schools, physician offices, and from the general community. Follow up is done within the reporting timeline as defined in the Administrative code.

In addition to the routine follow-up, there are outbreaks of communicable diseases that need to be investigated and resolved in a timely manner. To deal with outbreaks, the Health District adopts a team approach based on the National Incident Management System (NIMS) model.

Some of the Highlights of 2011 are as follows:

- There were a total of eight outbreaks that were investigated. The outbreaks included Norovirus (5), Cryptosporidiosis (1), Varicela (1) and Unknown Etiology (1).
- Five cats tested positive for Tularemia (Class I a) although there were no human cases.
- Resurgence in the number of cases of Pertussis. Although not a significant number to create panic, there was a steady increase in numbers and a significant number from neighboring counties.

In addition to investigation and follow up of cases, the communicable disease staff also conducted on-site infection control training and support for community agencies including daycares, nursing homes, and schools. Other prevention strategies implemented during the course of the year includes annual reminders to all providers regarding reporting mandates as well as a yearly training for all school and daycare staff reminding them to be the eyes and ears of Public Health in the community.

Hand washing is the single most effective way to prevent the spread of infections.

Emergency Preparedness Program

The Emergency Preparedness Program at CUPHD provides education, community support, and hands-on training in regard to public health for Champaign County. The goal of the Emergency Preparedness Program is to prepare Champaign County for active public health response in the event of a large-scale emergency.

Emergency preparedness activities include meetings held at local, state, and regional levels with corresponding training activities and exercises. Local meetings include, but are not limited to, monthly emergency management meetings, an infectious disease working group at the University of Illinois, a Champaign County Public Information Officer workgroup, and educational outreach with community churches, schools, and other agencies. State and regional activities include, but are not limited to, the Illinois Department of Public Health's Health and Medical Task Force, Regional Health Department Emergency Response Coordinator's meetings, and the 2011 IDPH Emergency Preparedness Summit.

Developments:

- Scored a 95 out of 100 points on the annual Local Technical Assistance Review for Strategic National Stockpile (SNS) Planning.
- All staff is trained and compliant with the National Incident Management System (NIMS) training for ICS 100b and 700a by directive ESF-8 (federally mandated Emergency Support Function).
- Multiple staff members took the HSEEP (Homeland Security Exercise and Evaluation Program) training course. Preparedness exercises continued to be HSEEP compliant throughout the year.
- Jane Li joined the CUPHD team as the new Emergency Preparedness Planner.




Finance


The responsibilities of the Finance Division include, but are not limited to, the following functions:

Human Resources

The Human Resource Department at CUPHD provides support services to ensure employees can meet the District's overall objectives.

CUPHD Garden

On Sunday, September 11, 2011 eighteen (18) additional raised garden beds were built on the north side of the District campus. All supplies and labor were provided by University of Illinois Student Volunteers doing community service in remembrance of the events of Sept 11, 2001. These additional beds

expanded the garden project to thirty (30) 8'x4' raised beds. The gardens are an on-going project to teach successful gardening techniques to clients and staff and to supply the weekly farmer's market with fresh produce which is made available to clients who come in for public health services.

Take Our Daughters & Sons to Work Day®

The 2011 annual Take Our Daughters and Sons to Work Day® was held on Thursday, April 28, 2011. The theme was "Invent the Future". Twenty-two (22) students with ages ranging between 4-13 participated.

Activities included petri dish experiments, "VERB, It's What You Do" Program sponsored by the CDC; hand washing demonstrations; gardening terrarium project; and a demonstration on healthy brushing/flossing techniques for healthy teeth.

Along with millions of others in Illinois, students also participated in the Great Central U.S. Shakeout, an earthquake preparation program sponsored by the Federal Emergency Management Agency.

Information Technology

Information Technology is directly responsible for all day-to-day electronic operations at CUPHD. In addition, Information Technology oversees the creation and updating of the CUPHD website, the CUPHD closed-circuit TV system, phone systems, and audio systems.

Information Technology staff members provide case-by-case solutions for electronic issues, computer trainings, and educational opportunities for CUPHD staff. Information Technology is the central resource for research and development of electronic upgrades and equipment.

PHIRE

Public Health Institute for Research and Excellence (PHIRE) is the research arm of the Champaign-Urbana Public Health District (CUPHD). The Institute was created in 2009 to promote best practices through quality education, training, technology, evidence-based research, and effective partnerships that bridges academia and the local community knowledge.

PHIRE continues to grow within the organization and the community. Some of the projects that were undertaken during the year are as follows:

- A portable CD4+ T cell counter for rapid HIV/AIDS diagnostics. In collaboration with the University of Illinois at Urbana-Champaign, Micro and Nanotechnology Laboratory.
- "The Association between Bacterial Load in Food and Environmental Surfaces of Restaurants and Public Health Documentation of Food-borne Illness Risk Factors Violations". In collaboration with University of Illinois, College of Veterinary Medicine.

- "Predicting the Time-Course of Attention to Health Information for High-Risk Audiences". In collaboration with University of Illinois, College of Psychology.
- Improving eating behavior through nutrition education for early prevention of obesity and type 2 Diabetes in Hispanic communities. In collaboration with the University of Illinois, Division of Nutritional Sciences.

Programs

Environmental Health

Environmental Health inspects food and drink establishments, reviews kitchen plans for new facilities, enforces environmental laws, issues permits for private water supplies and private sewage systems, conducts surveillance and abatement for mosquitoes transmitting West Nile virus, and provides foodhandling classes.

Body Art Program

CUPHD inspects body art establishments in Champaign and Urbana. Body art includes body adornment techniques such as body piercing, tattooing, cosmetic tattooing, branding, and scarification. It does not include establishments that pierce the non-cartilaginous portion or lobe of the ear with pre-sterilized single-use stud-and-clasp ear-piercing systems.



Food Protection

All restaurants, retail food stores, temporary food booths, taverns, convenience stores, and other types of food services must obtain a health permit to operate.

Environmental Health conducts unannounced inspections at all food service establishments, reviews plans for newly constructed or remodeled facilities, investigates complaints, provides educational classes and information to food service workers, and initiates legal proceedings for non-compliance. As part of an intergovernmental agreement, Environmental Health issues city food handler's licenses on behalf of the cities of Champaign and Urbana.



Environmental Lead Investigations

Environmental Health investigates the source of lead exposure in children with lead poisoning. When necessary, an environmental lead assessment is done to determine the source(s) of hazardous lead exposure in the residential environment of children with elevated blood lead levels. Inspection reports and compliance letters are generated and, when necessary, legal prosecutions are initiated. Environmental Health also provides educational materials to renters, landlords, and homeowners.

Mosquito / West Nile Virus (WNV) Program

Environmental Health monitors local populations of mosquitoes for West Nile virus infection. Environmental Health also collects dead birds in Champaign County for West Nile virus testing. This information assists in tracking and alerting the public in areas that are more likely to contain infected mosquitoes.

In 2010, CUPHD signed an intergovernmental agreement with the cities of Champaign and Urbana and the Village of Savoy to provide a *Culex* mosquito prevention program. A main component of this agreement was larvicide applications to catch basins to reduce mosquito populations.

Potable Water Program

Environmental Health issues permits for new well installations, inspects and tests new wells, and makes sure that abandoned wells are sealed. Environmental Health also tests and inspects noncommunity water supplies.

Private Sewage Disposal Program

Environmental Health reviews construction plans and applications for all private sewage systems and issues permits upon approval. Inspections are performed on new systems, renovations or repair work, or as a result of complaints.

Radon Program

Radon is a naturally occurring, invisible, odorless gas that comes from deposits of uranium in soil, rock, and water. Environmental Health periodically offers short-term radon test kits to Champaign County residents at no cost.



Tanning Program

All tanning establishments in Champaign County must follow the guidelines of the Illinois Department of Public Health (IDPH). Environmental Health inspects public tanning facilities and responds to complaints.

Infectious Disease

The Division of Infectious Disease Prevention and Management is made up of nurses, counselors, substance abuse professionals, and case managers. The goal is to provide all available services to the individual where CUPHD has contact with them. Risk reduction counseling and risk reduction supplies are provided in all services. Immediate, onsite referral to Care Connect services are provided to all persons who test positive for HIV infection. Partner Counseling and Referral Services are offered to all persons who have an STD or HIV. HIV and Hepatitis support groups are offered monthly for persons infected or affected.

Check Out Healthy (Jail Project)

"Check Out Healthy" is a collaborative effort between the Champaign County Correctional Facility and the CUPHD Infectious Disease Division. "Check Out Healthy" is a transitional case management program that offers pre-release support, free communicable disease screening, and discharge planning. The program is offered to all inmates who are HIV+, and those at an increased risk for becoming HIV+, who are housed at the Champaign County Correctional Center, All inmates are offered HIV and syphilis testing. Those 25 years old and younger or that report STD symptoms are offered urine testing for Gonorrhea and Chlamydia during a weekly on-site clinic.

Chlamydia Evaluation Project

This CDC initiative is aimed at increasing testing options for sexually-active women 12 to 25 years old who presented for health services at a physician's office, emergency room, or clinic. In 2011, an expert from the Chicago Department of Public Health presented at a physician's forum at Carle. Attendees received information on the importance of Chlamydia testing.



CUPHD Mobile Program

CUPHD currently has two (2) mobile units that provide HIV/STD services to Champaign County clients in their neighborhoods during times that are most accessible to the residents. This program provides an innovative solution for those residents that desperately need CUPHD services, but are unable to access them due to transportation or scheduling challenges.

Neighborhoods that have received monthly visits from the CUPHD mobiles have included a strip mall in Rantoul; Fair Oaks in Danville; Good Samaritan Soup Kitchen in Decatur; Catholic Worker House, and Scottswood in Champaign. CUPHD mobiles are also available for events such as neighborhood and church health fairs and much more!

Teen WOW (Wellness on Wheels) is now in three (3) Champaign high schools and one (1) Rantoul high school.

Gonorrhea Elimination Project

This IDPH initiative attempts to ensure that all sexual partners of those who are found to have Gonorrhea in Champaign County receive testing and treatment. Through this project, CUPHD staff contact all persons who test positive for Gonorrhea in the county, conduct a short interview about their disease, and locating information about their sexual partners to ensure that they are tested for Gonorrhea and properly treated.



Hepatitis Integration Project

The Hepatitis Integration Project assesses risk factors for viral Hepatitis among all clients and performs appropriate testing for HCV infection. The Hepatitis Integration Project provides a client-centered viral Hepatitis prevention counseling and support group, and provides Hepatitis A & B immunizations to persons in appropriate risk groups.

HIV Care Connect

CUPHD serves as the Lead Agent for the East Central Illinois HIV Care Connect which serves the following counties: Champaign, Clark, Clay, Coles, Crawford, Cumberland, Douglas, Edgar, Effingham, Ford, Iroquois, Jasper, Kankakee, Lawrence, Livingston, Richland, and Vermilion. Case management is provided to persons living with HIV in each county.

In 2011, persons living with HIV were offered medical case management at CUPHD. Medical case management is a formal and professional service that links clients with chronic conditions and multiple service needs to a continuum of health and social service systems. This system strives to ensure that clients with complex needs receive timely coordinated services which assist a client's ability to function independently for as long as is practical. Medical case management assesses the needs of the client, the client's family, and the client's support system as well as arranges, coordinates, monitors, evaluates, and advocates for a package of multiple services to meet the specific client's complex needs.

HIV Testing & Counseling

Infectious Disease provides HIV testing and counseling services to those most at risk for HIV infection. Testing is available using Orasure or rapid testing devices. Testing is provided at the CUPHD clinic (201 West Kenyon Road), on the CUPHD mobiles, and in outreach settings.



Juvenile Detention Center Outreach

STD education and urine screening for Chlamydia and Gonorrhea is offered to all of the youth during a weekly on-site STD clinic.

Men's Screening Clinic

Infectious Disease staff provides a special Men's Clinic for STD services at the CUPHD clinic at 201 West Kenyon Road. This clinic is available to walk-in clients on Mondays (4:00 - 5:30 PM).

Services include testing, treatment, and counseling for the following: Chlamydia, Gonorrhea, Syphilis, Hepatitis C, HIV, Herpes Type 1 & 2. Additional services include Hepatitis A & B vaccines.

Mpowerment Project

This community-level intervention for young men who have sex with men uses a combination of informal outreach, discussion groups, creation of safe spaces, social opportunities, and social marketing to reach a broad range of young gay men with HIV prevention, safer sex, and risk reduction messages.

In 2011, an Mpowerment project for young African American men who have sex with men, "Brother to Brother", was continued. This project follows the same model but adds components of race and cultural identity to increase HIV prevention.

Pregnancy Screening Project

Clients, 25 years of age and younger or those who report STD symptoms, that present for pregnancy testing are provided "opt-out" testing for Gonorrhea and Chlamydia with the urine specimen they provide for pregnancy testing.

STD Services

CUPHD provides STD services at 201 West Kenyon Road on Tuesdays (1:00 - 5:00 PM) and Thursdays (9:00 - 11:00 AM & 1:00 - 3:00 PM). Services include counseling, testing, and treatment for the following: Chlamydia, Gonorrhea, Syphilis, Hepatitis C, HIV, Herpes Type 1 & 2. Additional services include Hepatitis A & B vaccines.

STD Surveillance

Infectious Disease provides surveillance services for clients that test positive for sexually transmitted diseases. CUPHD staff works confidentially with any clients that test positive for STDs to locate, test, and treat sexual partners.

Tuberculosis (TB) Program

One-third of the world's population is infected with Tuberculosis (TB), and one (1) person with active TB can infect 10-15 other people in a year! CUPHD offers TB skin tests every week and follow-up treatment when needed for those who test positive. Field TB testing is available for at-risk groups. CUPHD also offers professional speakers to make TB presentations upon request.

In 2011, CUPHD managed five (5) people with active TB disease through Directly Observed Therapy (DOT).

VOICES Program

The VOICES program (Video Opportunities for Innovative Condom Education and Safer Sex) is a group-level, singlesession video-based intervention designed to increase condom use among heterosexual African American and Latino men and women in their community. VOICES is offered in the adult and juvenile correctional facilities.

Did you know...



Maternal & Child Health

Maternal & Child Health (MCH) provides services to at-risk mothers and children in Champaign County. Services include WIC, Immunizations, Lead Poisoning Screenings, HealthWorks, Family Case Management, Nutrition Counseling, and MUCH MORE!

Cooperative Extension

CUPHD has an agreement with the Cooperative Extension office in Rantoul to provide classes to WIC-registered clients.

Family Case Management

Family Case Management provides preventative care, developmental testing, immunizations, referrals, and follow-up for pregnant women and children who meet income guidelines. Home visits are done once during pregnancy and once during the postpartum period. The car seat program is in collaboration with Safe Kids of Champaign County. The Illinois Department of Public Health (IDPH) Genetics Grant provides funding for prenatal genetic screening. Denver II and Ages and Stages standardized developmental screenings are used and the Edinburgh tool is used for postpartum depression screenings.

Farmer's Market

CUPHD hosts a produce-only Farmer's Market onsite each Tuesday afternoon from June to October, as a point of access to healthy foods. WIC Farmer's Market Vouchers, cash, and LINK/SNAP benefits are accepted for payment.

HealthWorks

HealthWorks for Illinois is a collaborative effort between the Department of Children & Family Services (DCFS) and Public Health. Public Health in Champaign County serves as the Lead Agency for Champaign, Ford, and Iroquois counties.

HealthWorks provides advocacy and referrals to pregnant DCFS wards and their children. HealthWorks works closely with foster parents and caseworkers to ensure that those in foster care receive appropriate medical care.


Lead Blood Draws

The Illinois Department of Public Health (IDPH) provides a grant to draw blood to check lead-levels for Medicaid clients age 1 and 2-1/2. If a child is found to have an elevated level, follow-up services, including a home assessment, are provided.



Parent Wonders

CUPHD has an agreement with the Parent Wonders program to visit the Rantoul office to provide support and parenting/child interaction skills education to clients that are participating in WIC services.



Summer Food Program

CUPHD acts as an open site for the Federal Summer Food Program and offers nutritious meals (breakfast, lunch, and afternoon snack) to any child 1-18, during the summer months. Many children receive a significant amount of their daily food from the school-based programs and this is missing when school is not in session. CUPHD works to fill this need. This is in collaboration with the Illinois State Board of Education and funded by Federal reimbursement.



Vaccines for Children

CUPHD provides immunizations to kids through the federal Vaccines for Children (VFC) program. There is no cost for these vaccines, and there is only a small administrative fee for each dose, which is billable to Medicaid.

Any child who lives in Champaign County AND who is a Native American or a Native Alaskan, OR is uninsured, OR has insurance that does not fully cover the cost of vaccination is eligible for vaccines. Underinsured children are eligible through an agreement with Frances Nelson Health Center.



Women, Infants & Children (WIC)

WIC provides nutrition assessment, counseling, and supplemental food coupons for "at-risk" pregnant and postpartum women, infants, and children up to age five.

Wellness & Health Promotion

Wellness & Health Promotion provides educational, supportive, and preventative programming to residents throughout Champaign County through the CUPHD Dental Clinic, the Urbana School Health Center, adult immunizations, the Illinois Breast & Cervical Cancer Program, Illinois WISEWOMAN Program, Vision Cooperative, Illinois Tobacco Free Communities, Coordinated School Health, various workshops, and health fairs.

Adult Immunization Program

CUPHD offers adult private pay and Health Alliance-insured immunizations by appointment. Payment is accepted by cash, check, credit/debit, or IPA card. The people served are approximately 45 percent from education programs for health vocations, 25 percent from immigration, and 17 percent mission and travel. The remaining 15 percent is a miscellaneous category including work needs, Consortia clients, injury requiring Td, and booster Tdap for persons caring for infants. The standard inject able immunizations are Hepatitis A, B or A/B, Tetanus as Td or Tdap, Mumps, Measles and Rubella, Varicella (chickenpox), Polio, and Typhoid.



Bone Up! Osteoporosis Prevention for Teens

Wellness & Health Promotion offers a three-session program for junior high and high school girls to teach them the importance of building bones now to prevent osteoporosis later. Participating girls learn the importance of calcium, foods that hinder and help the absorption of calcium, and make customized plans to increase the amounts of calcium they receive everyday. Participants also learn to make healthy calcium-rich snacks, the importance of weight-bearing exercise, and earn great gear to assist them with increasing this activity.

Break the Habit

Break the Habit is a partnership between the Illinois Tobacco Quitline and CUPHD. Residents of Champaign County interested in quitting can call the Tobacco Quitline to receive individual phone counseling from Addiction Specialists. CUPHD will provide the client with nicotine patches based on the recommendation of the Addiction Specialist.

Child Vision & Hearing Screening

The CUPHD Vision and Hearing Screening Program provides state-mandated hearing and vision screening to licensed day care facilities, preschools, private schools, and parochial schools upon request. CUPHD employs state-certified auditory and vision technicians.

Coordinated Approach to Child Health (CATCH)

CUPHD supports schools who are interested in implementing the CATCH program. CATCH consists of four (4) components to help keep children moving and eating right: Health Education, CATCH PE, Home Team, and school nutrition. Schools go through a full day of training, and receive the curriculum and support to implement the program. There are a total of five (5) schools in Champaign County that participate in CATCH.

Additionally, CATCH encourages "Moving Mondays" & "Fitness Fridays". These are days that schools participating in CATCH ask students to move when told to (over the school intercom system). CUPHD also supports CATCH schools through a variety of activities, for example structured physical activities at recess and Lucky Tray Day.



CUPHD Dental Program

The CUPHD Dental Clinic sees children ages 1-18 enrolled in Champaign or Urbana School Districts. Services include: cleanings, fluoride, x-rays, sealants, restorative care, and extractions.

As part of expanded services, the CUPHD Dental Clinic provides exams to children ages Pre-K-8 in their schools, using mobile dental equipment. Children who meet eligibility requirements also receive cleanings, sealants, and fluoride.

The CUPHD Dental Clinic also provides some oral surgery procedures one (1) Saturday per month for patients of record. Fluoride varnish and oral health risk assessments are also done in Maternal and Child Health / WIC by RNs and LPNs.





Give Kids A Smile® Day 2011

Freedom from Smoking

Freedom From Smoking is an eightsession class that focuses on giving participants the tools to successfully quit. This program is available to residents of Champaign County who want to live tobacco-free. Before participants quit, they look at their habit and the reasons for wanting to be tobacco-free, and develop a customized individual plan to quit. Nicotine patches are offered with this program.



Hand Washing Education

Wellness & Health Promotion offers a series of age-appropriate hand washing and flu prevention education programs and materials for all local schools. Schools may request these programs FREE by calling Nikki Hillier at 217.531.2914.

Illinois Breast & Cervical Cancer Program (IBCCP)

The Illinois Breast & Cervical Cancer Program (IBCCP) contracts with local medical providers to provide FREE breast and cervical cancer screening for women ages 35-64 with no health insurance, Medicaid, or Medicare part B.



The CUPHD IBCCP program serves women from Champaign, McLean, and Vermilion Counties. IBCCP provides community outreach, as well as educational materials and presentations throughout the IBCCP service area. IBCCP encourages all women to have their annual screenings done and seeks new client enrollment in order to provide screenings for uninsured women who would otherwise have no access to these services. Approximately 40 percent of the screenings yield abnormal results requiring IBCCP medical case management and diagnostic services. While women under the age of 35 are not eligible for screening through this program, they may be eligible for medically indicated diagnostic services if referred by their medical provider. If diagnosed, eligible women are transferred into Medicaid for cancer treatment.



Illinois WISEWOMAN Program

The Illinois WISEWOMAN Program (IWP) is a cardiovascular disease (CVD) risk-factor screening, intervention, and evaluation program that is currently being implemented among women who participate in the Illinois Breast and Cervical Cancer Program (IBCCP). IWP provides services for low-income, underinsured, or uninsured women ages 40 to 64. The IWP aims to reduce heart disease and other chronic disease risk factors through screening and lifestyle interventions that target blood pressure, cholesterol, diet, physical activity, and tobacco cessation.

Juvenile Detention Center Outreach

Wellness & Health Promotion health educators provide a variety of programs to the youth in the Champaign County Juvenile Detention Center throughout the month. Topics include, but are not limited to, sexual health, nutrition, and tobacco-free living.

Let's Get It Started

Let's Get It Started (LGIS) is a program that, in collaboration with University of Illinois Extension and County Market, helps families plan, purchase, prepare, and enjoy cost-effective and healthy meals together. Families also participate in a variety of fun activities to promote getting up and moving. Subjects covered include portion control, label reading, food and fire safety in the kitchen, food demonstrations, and a grocery store tour with a nutritionist.

Media Sharp

Media Sharp is an important tool to help middle and high school youth evaluate media messages and make healthy, life-saving choices. Through four to five interactive sessions using various forms of technology and media, participants learn how media influences our behaviors and decisions. The curriculum focuses on tobacco and alcohol, but addresses media's influence on all of our choices from cars to tennis shoes.

Not Here

Not Here is a tobacco sales compliance program for Champaign County. CUPHD notifies all tobacco vendors that they will be checked periodically for age 18 tobacco sales compliance. Congratulatory letters are sent to stores that pass "secret shopper" compliance tests. Reports on stores that fail compliance testing are forwarded to local law enforcement, who do an official check for compliance. CUPHD conducts "Not Here" checks three (3) times a year.

Not-On-Tobacco

Not-On-Tobacco is a cessation program for youth. It is a 10-week program for ages 12-17. N-O-T helps teens understand why they smoke and helps them develop the skills, confidence, and support they need to quit. Teens learn the skills they need to tackle tough problems such as nicotine withdrawal, cravings to smoke, and peer pressure to continue smoking.

Nutrition Education

Smoke Free Illinois Compliance

Smoke Free Illinois Compliance is an education and enforcement program for Smoke Free Illinois. CUPHD is responsible for receiving and investigating complaints for Champaign County, including those made to the State of Illinois, the smoking complaint hotline at CUPHD, and the CUPHD website. CUPHD will help businesses to comply where possible, and issue citations when appropriate.

Tar Wars

Tar Wars is a three-session program delivered in 4th and 5th grade classes. This program's focus is on changing normative beliefs about the prevalence of tobacco use. Further, instead of giving participants reasons not to use tobacco, it equips participants with decision-making and effective communication skills. Through this program, students get a chance to develop countermarketing strategies.

Tobacco Education

Training Intervention Procedures (T.I.P.s)

Wellness & Health Promotion provides an alcohol serving training program for all local businesses that serve alcohol. CUPHD partners with the Champaign Police Department and Prairie Center Health Systems to bring this program to area alcohol servers.

Urbana School Health Center (USHC)



The Urbana School Health Center (USHC) consists of a seamless partnership of trusted local agencies dedicated to the health and well being of children enrolled in the Urbana School District.

Services are available to ALL students of the Urbana School District during their school day, allowing for consistent and convenient carefree medical and dental services. Services include routine exams and procedures; acute care issues stemming from injuries or chronic disease conditions; and counseling and wellness programs. USHC's community care approach ensures the Urbana School District students the best possible care - away from home.

The Urbana School Dental Clinic sees children enrolled in the Urbana School District. Services include: cleanings, fluoride, x-rays, sealants, restorative care, and extractions.
