

BOARD OF HEALTH Monthly Meeting June 11, 2018

On June 11, 2018, the Board of Health of the Champaign-Urbana Public Health District (CUPHD) held a Monthly Meeting at 201 W. Kenyon Rd., Champaign, Illinois. Mr. Pius Weibel called the meeting to order at 4:34 PM. Upon roll call, the following board members were found to be present: Mr. Pius Weibel, Chair, and Mr. Andy Quarnstrom. Ms. Danielle Chynoweth, Secretary, was absent.

Mr. Andy Quarnstrom made a motion to approve the agenda. Mr. Pius Weibel seconded the motion. With all in favor, the motion carried.

Correspondence – Ms. Julie Pryde reported onThe Kresge Foundation "Emerging Leader Program". She and Mr. Awais Vaid have been moved forward in the selection process. Ms. Pat Robinson has submitted a Workforce Development Challenge to ASTHO and if won would be worth \$10,000 towards improving CUPHD's current workforce development training. Ms. Robinson is also working on a Barriers to Accessibility Grant through the managed care organization, IlliniCare. She has submitted a grant requesting funding for two handicap accessible exam chairs and has been short-listed for funding.
